Entries will be accepted in order of receipt. All entries must be accompanied by entry fees to be valid. There will be a \$25.00 fee for all returned checks. Judges are limited to 8 hours of judging and a maximum run value, which will require this club to limit entries accordingly. Late and/or Day of Show entries are not a guaranteed entry and will be accepted only up to Judging limits. Confirmations will not be sent for late entries. Any Judge of Record at this Event may be used in any ring. Qualifying scores will show the Judge who designed the Course.

Line Drive – Line Drive will be held after lunch and will be open to run for 2 hours.

Fees

Instinct (\$15.00) Novice (\$22.00) Open (\$25.00) Senior (\$30.00) Master (\$30.00) Crazy 8's (\$30.00) Line Drive (\$15.00) Late and DOS entries are accepted unless entry limits have been reached for an additional fee of \$5.00 per run.

This trial is at a working farm with Cattle, Sheep, and Chickens. Please do not allow your dog to harass the animals and do not allow them in any of the animal enclosures. Failure to comply and you may be expelled from the property.

Move Ups: Move-ups will be possible between tests, on the same day (Friday and Sunday), and from day to day.

Handicap Accessible: This site is not handicap accessible.

Notice to Participants

It is expressly understood that participants alone are responsible for the behavior of their dogs and/or children. Any participant whose dog and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the event committee, be asked to leave the event site. In such case, no refund of any fees paid will be made. Kristy Netzer, Michael Shirley and its agents, employees, etc., will assume no responsibilities for any loss, damage, or injury sustained by participants or spectators, or to any of their dogs or property and further assumes no responsibility for injury to children.

Kristy Netzer reserves the right to decline entries for cause and may remove any dog because dog or human aggression. No one shall have any recourse or claim against Kristy Netzer or Michael Shirley or any official thereof.

Exhibitor Information

Dogs must be leashed or crated when not actively working. Please pick up after your dog and dispose of waste in appropriate containers outside the building.

Ring Information/Location:

All classes will be under cover inside an open barn. The flooring is dirt OR tarp. The rings will be enclosed by 5' walls and 4' lattice fencing.

Blind:

The blind is located inside the barn on astroturf.

Handlers are expected to be in or near the blind area so they can get into the blind as soon as the last dog in the blind enters the ring. We will not hold up a blind unless a handler was working in the ring. We ask that handlers not

work the ring before their blind unless we are desperate for help. There will be 5-6 dogs per blind for Novice/Open and Crazy 8's. Senior will have 5, and Masters will have 4.

Safety: At all times, the safety of the dogs, handlers, and rats is to be of paramount importance. Rats will be humanely handled and safety confined in aerated PVC tubes; Barn Hunt is not intended to harm or kill rats.

Crating: There is limited crating in a few horse stalls in the barn and you can crate in the building on the foam matting at one end of the barn. Most participants crate out of their vehicles.

Leashes and Collars: Flexi-leads are forbidden inside the buildings. Electronic collars/devices and head halters are not allowed.

Collars in the Ring: Dogs may not be brought to the gate in any disallowed collar or on a Flexi-lead. Dogs MUST run "naked," without a collar/harness. Dogs should be brought to the ring with collars/harnesses which can be easily and quickly removed and replaced.

Bitches in season: Are eligible for entry but will be required to be kept separate from all other dogs and will run at the end of their class/trial. Entry fees for bitches that come into season will be refunded until the closing time if you wish to withdraw. If bringing a bitch in season, please inform the trial secretary prior to the trial.

Refunds: No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee. Entry fees will not be refunded in the event that a dog is absent, disqualified, sick, excused, or barred from competition by action of the Event Committee.

Refunds are ONLY allowed if requested before the closing date.

Payment and Forms: All entry forms are required to have all information completed including the Barn Hunt number; height; signature, etc. Payment must be sent at the same time. Incomplete forms, nonpayment and returned checks do not constitute a valid entry fee. There is a \$25.00 returned check fee.
